

1. Each eligible membership shall be permitted to register up to five (5) vehicles, subject to verification that the vehicles are owned by the Member.
2. Complimentary parking privileges shall apply only to the first two (2) registered vehicles entering the Club at any given time. Parking charges shall be imposed on the third and all subsequent registered vehicles parked simultaneously.
3. Any parking fees incurred for the third and subsequent registered vehicles parked simultaneously in the Club are strictly non-refundable.
4. A valid Car Park Label shall be prominently displayed on the registered vehicle at all times while parked within the Club premises.
5. The Car Park Label is tied to the registered vehicle and its car plate number. Any use of the label on a vehicle with a different car plate number is prohibited.
6. Any change in vehicle shall be promptly notified to the Club and the Car Park Label surrendered, failing which an administrative fee of \$50 shall apply.

BYE-LAWS 37. VEHICLE PARKING

(a) Registration and Parking Label

Members' motor vehicles are permitted to park at the Club only if they:

- (i) are registered with the Club for parking, that is, their In-Vehicle Unit ("IU") number is registered with the Club; and
- (ii) display on their windscreen a valid parking label with vehicle registration number ("VRN") that is issued by the Club ("Parking Label").

(b) Registering Vehicle

- (i) A Parking Label is issued for a Member's vehicle only when, on application, the vehicle is registered.
- (ii) Each Honorary, Life, Ordinary, Term, Silver and Associate Member is permitted to register up to five vehicles, but only two vehicles may be parked at the Club at any one time. Hourly parking charges will apply to the third and subsequent vehicles if they are parked concurrently as the first two vehicles.

For the first two vehicles, the Member must provide proof of authority to drive both vehicles. For any additional vehicles registered thereafter, the Member must show proof of ownership and that the additional vehicles are registered under the Member's name.

The application form for registration is available at the Front Desk and the Membership Department. The duly completed form (containing the IU number, VRN and other particulars/documents as required by the Committee) may be submitted at either of these places. When the vehicle is duly registered, it will be issued with a Parking Label. If there is a change of the vehicle's IU number, the Member must inform the Club.

- (iii) Each Honorary, Life, Ordinary, Term, Silver and Associate (under Rule 15(iv)) Member is permitted to register up to five vehicles.
- (iv) The Member shall notify the management within 7 working days of any changes including and not limited to change of ownership or authority to drive any registered vehicle. Failure to do so will result in the voiding of the registration of vehicle.

(c) Handling of Parking Label

- (i) A Parking Label issued for a particular vehicle is not transferrable to another vehicle. The Member must ensure that the Parking Label displayed on the windscreen of a vehicle is the Parking Label issued for that vehicle only.
- (ii) Where a Member has changed the VRN, sold, or otherwise disposed of a vehicle registered for parking, the Member must promptly notify the Club to de-register the vehicle and at the same time, or not later than 1 week after notifying the Club, surrender the Parking Label to the Club.
- (iii) If there is a breach of Bye-Law 37(c)(i) or 37(c)(ii), the Member is liable to an administrative fee of \$50 and may be subject to disciplinary action.

(i) Prohibition of Advertisements

Except for the vehicle's make, model, manufacturer's name and logo and such like, a vehicle intended to be parked at the designated parking lots should not carry any clearly visible advertisement of a commercial or trade nature, whether in the form of words, logo, or other forms of pictorial representation. Notwithstanding that a vehicle has been registered and issued with a Parking Label; the vehicle will not be permitted to park at the Club if it breaches this regulation.
